#### सीएम डॉ.मोहन यादव की अध्यक्षता में कैबिनेट बैठक



जीतू पटवारी ने सोशल मीडिया प्लेट फार्म पर लिखा मध्यप्रदेश के हरदा में एक अवैध पटाखा फैक्ट्री में ब्लास्ट की सचना मिली। बताया जा रहा है हादसे में लोगों के मारे जाने और कई के घायल होने के अलावा, 60 से ज्यादा घरों में आग भी लग गई है। वे शासन से अनुरोध करता हूं, हादसे की विस्तृत जांच करवाएं। घायलों के उपचार की व्यवस्था भी तत्काल सुनिश्चित हो। उपनेता प्रतिपक्ष हेमंत सत्यदेव कटारे ने एक्स पर लिखा- हरदा स्थित पटाखा फैक्ट्री हादसा बेहद ही दर्दनाक और अत्यंत दुखद है। इस भीषण हादसे में कई लोगों की मौत की खबर है और कई गंभीर घायल हुए हैं। हादसे का खौफनाक मंजर बीजेपी सरकार

#### स्कूलों में क्यों घट रही बच्चों की संख्या

# 12वीं कक्षा की परीक्षा शुरू, सात लाख से अधिक विद्यार्थी हुए शामिल

भोपाल,(निप्र)। मध्य प्रदेश में सोमवार से दसवीं कक्षा की परीक्षा शुरू होने के बाद दूसरे दिन मंगलवार से 12वीं कक्षा की परीक्षा भी शुरू हो गई है। 12वीं की परीक्षा में कुल 7 लाख 48 हजार 238 स्टूडेंटस शामिल हुए। कक्षा 12 के लिए 3 हजार 638 परीक्षा केंद्रों की व्यवस्था की गई है। इसके साथ ही 309 केंद्र संवेदनशील चिन्हित किए गए हैं। परीक्षा के दौरान अनचित व्यवहार के इतिहास के कारण राज्य में कुल 309 परीक्षा केंद्र जांच के दायरे में हैं। कक्षा 10वीं और 12वीं के छात्रों के लिए एमपी बोर्ड परीक्षाओं के मद्देनजर, संबंधित अधिकारियों ने कई संवेदनशील परीक्षा केंद्रों की पहचान की है। जहां 10वीं कक्षा के लिए 302 केंद्र

संवेदनशील बताए गए हैं। वहीं 12वीं कक्षा के लिए 309 संवेदनशील केंद्र चिन्हित किए गए हैं।

भोपाल में 10 अति संवेदनशील केंद्र- एमपी बोर्ड परीक्षाओं के लिए राज्य भर में 10वीं के छात्रों के लिए 3 हजार 863 और कक्षा 12 के लिए 3 हजार 638 परीक्षा केंद्रों की व्यवस्था की गई है। 10वीं कक्षा की परीक्षाएं 28 फरवरी तक और 12वीं कक्षा की परीक्षाएं 4 मार्च तक होने वाली है। 12वीं कक्षा की परीक्षा में कुल 7 लाख 48 हजार 238 छात्र छात्राएं शामिल होंगे। जिनमें 3 लाख 61,360 लड़िकयां और 3 लाख 86,878 लड़के शामिल हैं। नकल रोकने की खास व्यवस्था- बता दें कि पिछले साल सोशल मीडिया पर 10वीं प्रावधान किया है।
